The Cyprus Chamber of Commerce and Industry (CCCI) is pleased to announce its participation in the **ICC Global Business Summit (GBS-2025)**, which will take place on **18-20 September 2025** at the Jio World Convention Centre in **Mumbai, India** ([ICC GBS 2025](#)). Organized by the Indian Chamber of Commerce, this international forum will bring together senior industry leaders, policymakers, investors, and innovators from around the world to discuss new business opportunities and explore strategic partnerships.

The Summit will feature high-level sessions, sector-focused discussions, and carefully arranged B2B meetings, providing a unique platform for companies to establish direct contacts with potential partners and investors. Due to limited capacity, booth participation will be offered on a first-come, first-served basis.

Companies that wish to attend the Summit without being represented at the booth will only need to pay the administrative fee of €400, which covers the Chamber's support, matchmaking efforts, and participation in B2B meetings.
